8. Evaluation of Proposal Files

Step 1: Evalutation of the eligibility of the service provider's profile, verify the Proposal Files eligibility

- Provider evaluation criteria are used, based on the "Passed" and "Failed" criteria. The service provider is assessed as meeting the requirements for the validity of the profile, Proposal Files eligibility if they "Passed" all the requirements from item 1, 4, 5, 6, 7 and Application for Bid (Form 1) and Price Proposal Table (Form 2) signed by supplier's legitimate representative (the official representative by law or the legitimately authorized person accompanied with the letter of authorization).

Step 2: Evaluation of the Provider's eligibility and capacity:

- Provider evaluation criteria are used, based on the "Passed" and "Failed" criteria. The service provider is assessed as meeting the requirements for the validity of the Provider's eligibility and capacity if they "Passed" all the requirements from item 2.
- Service providers that pass the evaluation step of Provider's eligibility and capacity will be evaluated at the Technical standards evaluation step.

Step 3: Technical standards evaluation:
