Entering Japan After Quarantine

For 14 days from the day after immigration*, Please follow the 5 points below.

Please respond to Questions (1) and (2) on the back as well.

*The day after immigration is counted as **day 1**.

1. Do not leave the Japan address you provided in the form for 14 days after entering Japan and refrain as much as possible from interacting with people.

2. Do not use any public facility for 14 days.

(Including trains, buses, taxis, domestic flights and other facilities used by a large and unspecified number of people)

3. Check your health condition every day for the 14 days.

- ✓ Measure you body temperature every morning to check if you have fever.
- ✓ Check if you have severe cough, breathing problems or other symptoms.
- ✓ Check if there is any loss in the sense of taste or smell.

 *Persons coming back from regions with particularly high COVID-19 infection rates (refer to the back) must report their health status. You may be contacted by health centers and other facilities for a follow-up on your health condition.
- 4. <u>If you show symptoms, such as coughing or fever, please wear a mask and take care not to infect anyone else.</u> When you go to a hospital or other medical facilities, <u>call the Consultation Center for Returnees and High-risk Contacts beforehand</u>. Inform them about your region of stay and visit the specified medical institution for a check up.
- **5.** Please do the following to prevent spreading the infection.
 - ✓ Wash your hands frequently.
 - ✓ Get sufficient sleep and nutrition.
 - ✓ If someone in your family or household is unwell, make sure that everyone else wears a mask as well and limit the number people who contact the person. infected.


