- For persons aged 11 years or more, a virology screening test (PCR) carried out less than 72 hours before boarding, showing no COVID-19 contamination;
- A sworn statement committing to seven-day self-isolation, if necessary, in one of the dedicated facilities designated by the authorities, and to undergo a virology screening test (PCR) at the end of the isolation period.
