



## Possession of a valid vaccination certificate will shorten part of the waiting period after entry into Japan, etc.

○ Who are entering from “Countries/regions that are not on target for staying at accommodation of the government” or “Countries/regions that are on target for staying 3days at accommodation of the government”, if you have a valid vaccination certificate, and during the 14-day waiting period at home, etc., you voluntarily take a test(PCR Test or Quantitative Antigen Test) on or after the 10th day after entering Japan, and report a negative result to the Ministry of Health, Labor and Welfare(Health Monitoring Center for Overseas Entrants), the remaining waiting period will be shortened.

○ Who are entering from “Countries/regions that are on target for staying 3days at accommodation of the government” and has a valid vaccination certificate, will not be required to stay at accommodation and be tested on the third day after entry.

The above measures will be applied to those who enter Japan on or after October 1, 2021.

※ Even if the above conditions are met, if you are instructed by the quarantine station or public health office to remain waiting, you must follow the instructions.

※ The above measures do not apply to children who are not of an age to be vaccinated.

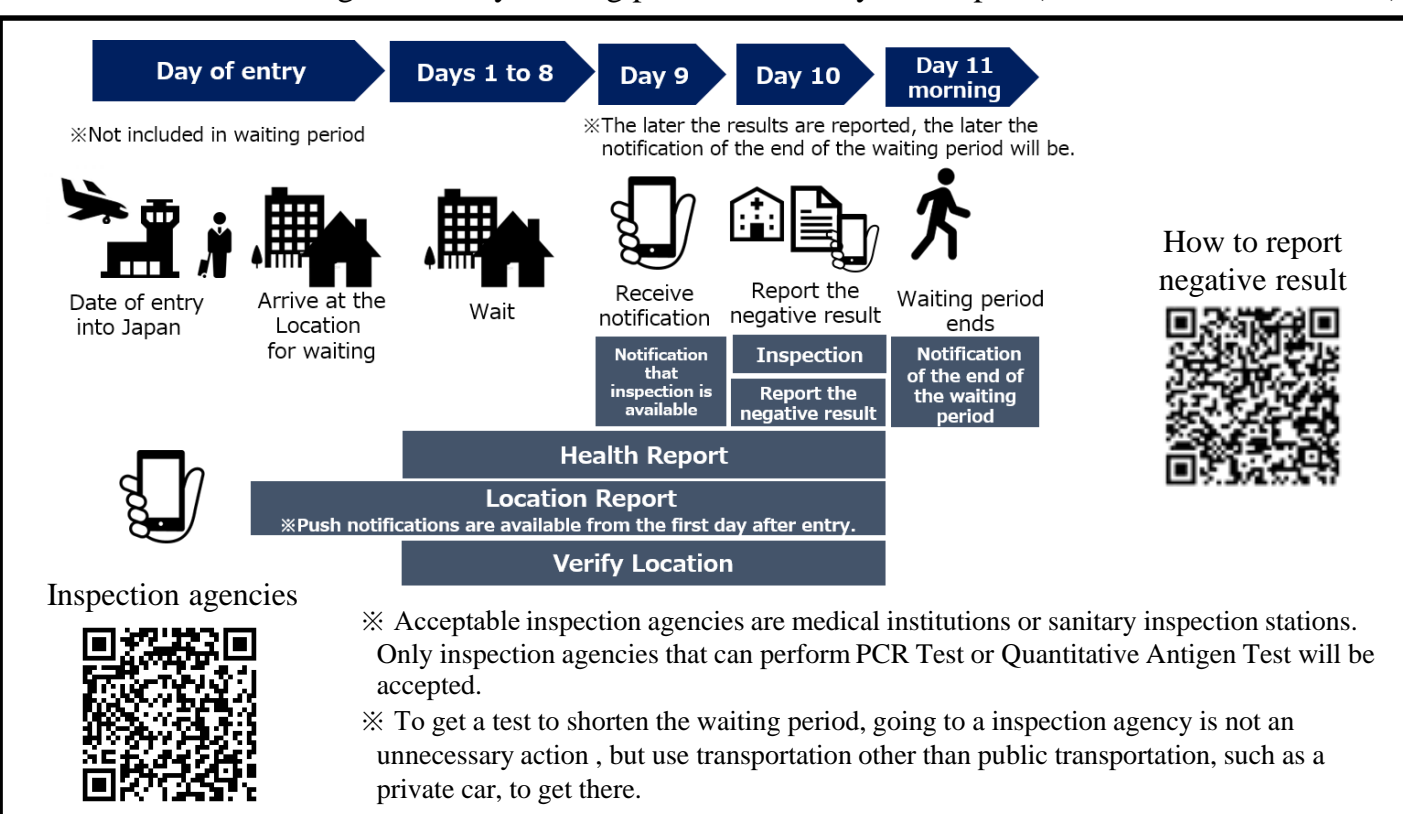

- Please submit a copy of the vaccination certificate to the quarantine officer.
- The vaccination certificate is valid only if it meets the following ① to ⑤.

①	<p>The certificate must be issued by a public institution in a country or region listed in the attached table.</p> <p>※ A vaccination certificate issued in Japan is valid for one of the following</p> <ul style="list-style-type: none"> <li>• Vaccination Certificate of COVID-19 issued by Japanese government or local governments in Japan</li> <li>• Certificate of vaccination for COVID-19 issued by local governments in Japan</li> <li>• COVID-19 vaccination records issued by medical institutions in Japan</li> <li>• Other certificates that are considered equivalent</li> </ul>
②	<p>The following items must be listed in Japanese or English</p> <ul style="list-style-type: none"> <li>• Name • Date of birth • Vaccine name/manufacturer • Date of vaccination</li> <li>• Number of vaccines administered</li> </ul> <p>※ Instead of the date of birth, other information that identifies the individual, such as passport number, is entered, the certificate will be considered valid if it can be verified that it is the certificate of the individual by comparing it with the passport.</p> <p>※ If the vaccination certificate is written in a language other than Japanese or English, it will be considered valid if it is accompanied by a Japanese or English translation and the contents can be identified.</p>
③	<p>It must be possible to confirm that the name/manufacturer of vaccine administered is one of the following.</p> <ul style="list-style-type: none"> <li>• Comirnaty / Pfizer</li> <li>• Vaxzevria / AstraZeneca</li> <li>• COVID-19 Vaccine Moderna / Moderna</li> </ul> <p>※ Vaccine name/manufacturer are those used in Japan.</p>
④	<p>It must be possible to confirm that at least two doses of vaccine has been administered.</p> <p>※ Both doses must have been given one of the vaccines in ③.</p>
⑤	<p>It must be possible to confirm that at the time of entry into Japan, at least 14 days have passed since the date of the second vaccination.</p>
