- **3.2.** In case of any discount, the bidder could submit the Letter of price deduction together with the bidding proposal or submit it separately provided that the Letter of price deduction is received by VNA before the deadline of Proposal's submission. If the Letter of price deduction is submitted together with the Proposal Document, the bidder must inform VNA before the deadline of Proposal's submission, or must have the list of the Proposal documents including the Letter of price deduction. The Letter of price Affiliate marketing. deduction must describe in details the contents and measures of deduction applied to specific items in the offered price.
- **3.3.** Bidding price should be fill-in according to Form 3, signed by the legitimate authorized person
- **3.4.** Valid time of Proposal Document
- **3.5.** Preparation and submission of Proposal Document
- a. The Proposal Document should be typed, printed with inerasable ink and continuous page numbers. The Application for bid, Letter of discount (if any), bidding price and supplementary documents to clarify the Proposal Document (if any) shall be signed by the bidder's legitimate representative. Inserted texts, erased texts, or overwrite in the typed document shall be

only valid if accompanied by the signature of the person who signs the application and with company stamp (if any).

- b. The Bidder may submit Proposal Document to the VNA directly or indirectly by courier, by email or by fax before the deadline of submission at **10.00h dated, 2019**. The Proposal Documents coming after the deadline of submission shall be non-responsive and rejected by VNA.

5. OTHER REQUIREMENTS

5.1. Preparation and submission of Proposal Document

5.1.1. Content of Proposal Document

- a. Proposal Document as well as all documents offer and exchanged documents relating to the competitive shall be made in English or Vietnamese.
- b. Proposal Document prepared by the Bidder shall include the following contents:
- Proof documents for the Bidder's eligibility:
- + The Bidder's Company Certificate of Registration;
- + List of Affiliate marketing contracts with other airlines;
- + Affiliate marketing introduction document.
- Application form for bidding as provided in Form 1.
- Letter of Authorization as provided in Form 2.
- Bidding price as provided in Form 3.
- List of similar contracts in Form 4.

The Bidder must prepare 01 (one) original of the Proposals.

5.2. Clarification of Proposal Document

a. During evaluating progress VNA may request the bidders to clarify some content in their Proposal Document (including the extraordinary unit price) and ask for supplementing documents in case of insufficiency. The clarification shall not result in any change of the main contents or quoted price of the Proposal Document. b. For the consideration, evaluation and comparison of Bid Proposals, VNA may ask any Bidder to clarify his Bid Proposals. The clarification of Bid Proposal may be conducted directly or indirectly in writing.

5.3. Evaluation of Proposal Document

Proposal Document will be evaluated in the following order:

- a. Verification of the eligibility of Proposal Document, including
- Eligibility of Bidder as stipulated in Section 4.1.
- The time of submission.
- Legitimate authorized signatures in application for bid, Letter of Authorization (if any).
- Valid time of Proposal Document as stipulated in Section 3.4.
- Those Bid Proposals are not satisfying any of the above requirements shall be rejected and shall not be selected for evaluation in the next stage.
- b. Evaluation of capacity and experience of the bidders

Bidding document will only be assessed as Pass if meet all the requirements set out in Section 4.1.

c. Technical evaluation

Those Bidding documents having passed the capacity and experience requirements shall be conducted in the technical evaluation stage with the criteria in Section 4.2. The evaluation of technical requirements is based on "Pass" and "Do not pass". The Proposals is considered to "Pass" the technical evaluation stage when all technical requirements must achieve "Pass".

d. Price evaluation

VNA shall evaluate the offered price of Bidding documents passing the Technical requirements. The Bidder with the lowest evaluated price will be the first in rank.

5.4. Criteria of the bid winner

The bidder that meets all following conditions shall be awarded with the bid:

- Having eligible Proposal documents.
- Having name in only one Project Proposal document as the main bidder and not violating the prohibited actions stipulated in Vietnam Bidding Law;
- Having the lowest evaluated price after correcting errors & adjusting deviations (if any) and the evaluated price that is not exceeding the approved price of the bidding package.

5.5. Announcement of the bid result

VNA will announce the Bid result to all participant in written after getting approval of the bid result.

5.6. Negotiation, completion and signing of the contract

VNA will conduct negotiation, completion the contract via email or at VNA head office with the bid winner for the contract singing after receiving written form of negotiation by the winner.

5.7. Petition in the bid

Within 10 days since the announcement of the bid result the bidders are entitled to petition for the bid result and any relevant issues in the bidding process within 10 days since the announcement of the bid result when their benefits and rights are thought to be impacted as stipulated in Article 72 and 73 of Vietnam Bidding Law, Chapter X, Decree 85/CP.
